Michigan Election Results & What's Next

AAUW MI Government Relations Coordinator Tuesday, January 24, 7:00 pm Zoom Meeting

On January 6th, the Michigan legislature will meet for the first time in 2023 to discuss and decide what bills they want to work on for the coming year. Mary Pollock, AAUW of MI Government Relations Coordinator, will present a program on how some of these new bills, if passed, will affect women. This is your opportunity to learn about issues of most concern to you so you can let your government representatives know what you want them to do.

Mary handles AAUW of MI priority legislative issues at the State Capitol including education that promotes gender fairness, equity and diversity, economic self-

sufficiency for all women as well as equality, individual rights and social justice for a diverse society. In 2011 she became the Legislative Representative for the Michigan State Employee Retirees Association for which she is a political adviser, writes a monthly newsletter column, and makes presentations to its chapters and other retirees around the state. She also became the first Government Relations Coordinator for the American Association of University Women of Michigan. She is the only multi-issue women's rights registered lobbyist and advocate covering Michigan state government.

Happy New Year: 2023! We hope that this issue of the Twig finds you happy and healthy and enjoying our Midland community. Our Midland Branch had a successful and interesting year. Sadly, we will miss some members who are no longer with us, as we remember their varied contributions, energy and support.

Here are some 2022 Branch highlights:

- Two very successful Book Sales, grossing over \$35,000 for future scholarships
- We gained 13 new members, and we welcome them!!
- \$20,000 in scholarships were given to deserving local students
- In April, our branch hosted the 100th anniversary of AAUW-Michigan and we celebrated eighteen 50year branch members
- Judi Cox received the "Young Leader Award" from AAUW-Michigan.
- We had several wonderful programs, with speakers as varied as the Midland Chief of Police, a Women's History expert, Recycling & Glass Smashers and Santa* himself! *actually, Fred Honerkamp from Midland's Santa House
- Most recently, thanks to a generous donation by one of our 50-year members, our branch bought \$1,000 worth of Meijer gift cards. With their special "Simply Give" event on 12/17, Meijer then double-matched this amount resulting in \$3,000 donated to Midland County Emergency Food Pantry.

The generosity of our community combined with the boundless energy and unmatched organizational ability of our branch members are the reasons that we continue to do well, providing scholarships and helping our neighbors. Thank you for all you personally do to make our branch and community better!

Public Policy Report ~ Jane Wirth

Michigan Recount: There were a few precincts selected to conduct recounts on Proposal 2 and Proposal 3. Results show there were very few changes in the vote count.

--For Proposal 2, the precincts conducting the recount had a total of 37,527 yes votes and 22,234 no votes. The recount total resulted in a gain of 14 yes votes and 20 no votes, changing it by a net of six no votes for a proposal that passed by more than 861,000 votes in its favor.

--For Proposal 3, there were 418,657 yes votes and 207,539 no votes in these precincts prior to the recount. After the recount, there were 116 yes votes and seven no votes gained, resulting in a net change of 111 yes votes for a proposal that passed by more than 583,400 votes in its favor.

The Board of State Canvassers voted on certifying the recounts Wednesday, Dec. 21.

Two days later, on Dec. 23, the proposals went in the Michigan Constitution. Child Marriage is still legal in Michigan as the fight continues to change the law.

Self-determination of one's reproductive health decision (one of AAUWMI Public Policy Priorities) is expected to fare better with the newly elected state legislators. We will stay tuned to proposed legislation.
